We collect and use personal information to:

Our website and Web Portal are hosted on the Wix.com platform and Linode cloud computing platform. . Wix provides secure cloud-based hosting, data storage, and payment processing services, and Linode provides virtual machine hosting.

Your data may be stored on Wix's or Linode's secure servers, which are protected by firewalls and industrystandard encryption.

Payment Security:

All direct payment gateways offered by Wix adhere to PCI-DSS standards managed by the PCI Security Standards Council (Visa, MasterCard, American Express, Discover).

We may share limited personal information with:

Trusted third-party service providers (e.g., IT, shipping, analytics, or marketing support) under contractual confidentiality

Law enforcement or regulatory agencies if required by law or court order

We do not sell, rent, or trade personal information
